Develops sales, plans, and forecasts.</p> <ul style="list-style-type: none"><li>• Pick up and deliver products, supplies, and equipment and run errands as directed by the Assistant Operations Managers.</li><li>• Maintain and preserve records associated with product pick up and deliveries</li><li>• Ensure all loads are secure and that securing devices are in good condition prior to transporting.</li><li>• Perform pre and post vehicle inspections to validate that vehicle is in safe operable condition and submit to management.</li><li>• Complete and submit driver logs to management in a timely manner.</li><li>• Maintain company vehicle by renewing inspection tags, licenses, and performing preventive maintenance as required and submit to management.</li><li>• Notify Operations Manager of any issues identified with the company vehicle and/or issues surrounding deliveries/operations.</li><li>• Perform work and drive the company truck in a safe manner including adherence to driving laws and company safe practices.</li><li>• Inform Operations Manager of any driving violations/tickets/incidents that occur.</li><li>• Perform housekeeping &amp; other general warehouse maintenance activities as needed.</li><li>• Maintain a current driver's license at the appropriate classification level.</li><li>• Maintain a current commercial driver medical certification on file with company.</li><li>• Maintain a safe driving record and be knowledgeable of all FMCSA regulations.</li></ul>
